Staff Reports -

Mrs. Casto reported that there will be a vacancy on the Town Economic Development Authority and the Board of Zoning Appeals as of July 1, 2018. Council members need to consider replacements for both of these boards.

Mrs. Ray provided the April 30, 2018 Financial Report. She is also currently examining Utility debts, Personal Property and Business License delinquencies.

Mrs. Earhart provided training and consultation in the middle of May. She discussed a few of the Town's unique situations and assisted with satisfying several of the auditor's questions. Mrs. Ray thanked the Town for allowing her the opportunity to use Mrs. Earhart.

Mrs. Ray will explore the Virginia Municipal League investment products. She will be looking at other options for the Town's investments.

Mrs. Ray stated that near the end of the summer or early fall, she will be looking into new financial software packages. Mrs. Earhart is also willing to assist with closing out the Town's books in the early fall.

The FY 2017 Annual audit – The auditors have one more question and Mrs. Ray is waiting for some guidance from Mrs. Earhart.

Mr. Shanaberger – none - absent

On a motion by Mr. McDearmon, seconded by Ms. Spiggle, Council voted to adjourn at 6:30 p.m. All members present voting aye. Motion carried 6-0.
